- 1. Call to Order by Fred Olsen. Confirmation of quorum (25).
- 2. Standing Orders for the 50th AGM: Robert's Rules of Order
- 3. Presentation of the amended minutes of the 49th Annual General Meeting. Minutes were amended to read "49th" AGM under item 2.0 and "48th" under item 3.0. Acceptance of the amended minutes moved by Dwayne Hlady and seconded by Frank Hoebarth. Carried.
- 4. Financial Report
 - Presentation of audited financial statement for April 1, 2016 March 31, 2017. There was a
 question on how the casino money was deferred. There was a question on the occupancy
 category and office costs. There was a question on how Laureen's position would now be paid.
 Moved by Gail Hiller and seconded by Marie Buchanan to accept the financial statement as
 presented. Carried.
 - II. Presentation of the budget for 2017-2018 for information only. Delores Ast wanted know when the budget would be approved by the members. After some confusion it was determined that the bylaws do not explicitly mention that the budget must be brought to the members for approval. The practice in the past has always been to bring the budget to the AGM but for information only. It is the Board who approves the budget and provides financial oversight at each Board meeting.
 - III. Re-affirm the auditor: Moved by Gail Hiller and seconded by Maria Buchanan to re-affirm Hawkings Epp Dumont as auditors for upcoming year. Carried.

7. Objects/bylaws: A member from Region 5 asked when was the last time the bylaws had been updated. The answer was two years ago.

8. Members Forum:

Vernie Monroe from the Region 5 Outreach Committee brought forward their assessment that many areas already have access to outreach information in their local areas and are not interested in information from ACA. They prefer to contact groups and people in their own localities. They felt their outreach efforts were really disappointing and that the ACA strategy needs to be rethought. Fred suggested that this should be part of the strategic planning session that will be happening in the fall and that every Region is invited to participate.

An executive director from a seniors centre came forward and said that part of the strategic planning should be to develop a link with the Seniors Centres Association of Alberta. She used to love being part of ACA when it brought the senior centres together but that function seemed to fade away. She found herself drawn to the new organization by necessity.

Some Region 5 members raised the issue of the rebate that goes back to the Regions still being at \$2 even though the membership fee itself has been raised several times.

Motion

That the membership rebate go to \$5 per member. Moved by Sandra Smyth. Seconded by Vernie Monroe.

Discussion took place on this motion. Paul Boisvert suggested that an entirely different funding formula be considered, including regional casinos. Fred Olsen suggested that this could all be part of the strategic planning process that is coming up in the fall. Someone asked if an immediate change in the membership fee would affect the current budget and the answer was yes. Gail Hiller (Treasurer) suggested that any change should be for next year because of the financial planning process. Sandra Smyth and Vernie Monroe agreed to amend their motion.

Amended Motion

The issue of membership rebates should be studied as part of the strategic planning process with information sent out to the Regions prior to the strategic planning process. Moved by Sandra Smyth and seconded by Vernie Monroe. Approved.

9. Adjournment: Gary Pool moved for adjourned. Fred Olsen adjourned the meeting.

Talking Points

In order to strengthen the "one voice" of Alberta Council on Aging, the Board of Directors recently voted on accepting the following as guidelines for discussion.

Housing

- seniors desire to reside in a place appropriate to their circumstances
- living environments such as outdoor spaces and buildings must support seniors to maintain themselves in the community

Finances

- seniors need to have adequate financial resources to meet their needs
- current supports for seniors are often based on a means tests which looks at income but fails to consider other expenses that may be incurred
- recommendation that needs testing be used to compliment current means tests and be related to individual needs

Continuing Care

- continuing care services for Albertans often impose significant costs for seniors
- support efforts to make continuing care services clearly and consistently defined
- affordable for all seniors

Transportation

- recommendation the provincial government undertake a review as to how transportation for seniors can be improved
- seniors require equal access to services wherever they live

Health

- equal access to emergency care, surgeries, hospitalization and treatment such as rehabilitation and medications
- seamless delivery of publicly funded and delivered programs and services
- clear standards and eligibility for programs and services
- expanded legislation for Protection for Persons in Care

Elder Abuse

- envision a world free of abuse
- work toward this aim through developing community partnerships
- make appropriate referrals for reporting and receiving help
- influence legislations which protect older persons

President's Report

My term as ACA President began quite unexpectedly with the resignation Fred Olsen in August 2017. To say there was a bit of a learning curve involved in filling the president's shoes would be an understatement! Since that day, the board has held three meetings. We have welcomed four new regional directors (Kim Winger, Keith Sterling, Brenda Josephs, and Gordon Nott), and accepted two resignations (Paul Boisvert and Dwayne Hlady). We're currently seeking directors for Regions 3, 7 and 9. In November I attended a seniors' advisory forum, hosted by Alberta Seniors and Housing, in Calgary. The forum provided an opportunity to share information and perspectives for the development of strategies to deal with three key priorities set by the minister: ageism, aging in community (housing and supports), and labour force participation of older workers. In February I attended the annual meeting of the Medicine Hat Senior Citizens Advisory Council. I presented information on the history and mission of Alberta Council on Aging. I was encouraged by the energy and enthusiasm shown by seniors in 'the Hat'. In March I attended the Alberta Seniors Communities and Housing (ASCHA) Convention and Tradeshow in Red Deer. ASCHA is a provincial organization serving the seniors housing sector. Its members include non-profit, public and private housing providers. The convention provided insight into initiatives of Alberta Seniors and Housing and Alberta Health in dealing with our aging population. Our next major effort has been preparing for the development of a strategic plan for Alberta Council on Aging, mapping our direction for the next three years. Stay tuned! In closing, I wish to thank the board members, regional executives and office staff for their patience and guidance - it's very much appreciated.

At an executive meeting, we considered the idea of rotating the executive of Region 2 among the various communities in our region in a two or three-year cycle. Perhaps people would be more prepared to serve on the executive, knowing there would be a limit to the time they would have to serve.

For geographic and travel reasons, it works well to have the executive living relatively near each other. However, it would be beneficial for ACA to have the executive shift on a regular basis from one part to another of our very large region.

The Region 2 annual meeting was held in the Redwater Seniors Centre with a good attendance. Redwater has a very spacious and Senior friendly centre, where we were pleased to hold our annual meeting in the Centre.

Paul Boisvert presented Recognizing Fraud, with great interest from those attending the meeting. Grant monies were awarded to 14 senior serving organizations in our Region 2. It is wonderful to acknowledge the various and beneficial activities that occur in our rural senior centres.

The challenges and concerns of our rural region remain huge. Great distances, challenges with ambulance services, the many government and health services being readily available in our rural communities, and being so far removed from the larger urban centres, the issues are not addressed in a proper time frame. In Region 2 we continue to address and advocate for the improvement of these problems.

Region 4

Our area participated in a number of events over the last year. We sponsored displays at a Seniors Housing Forum in September and a Seniors Health and Wellness Forum in November. At each of these events we had several hundred people visit our display. Many of them were interested in our activities.

We had a regional meeting also in November with about 25 members attending and presented our Recognizing Fraud program in March to a group of members and general public. The presentation and follow-up discussions were appreciated by the attendees.

In addition to these activities we represented Alberta Council on Aging at a number of discussions, this included several Seniors' Task Force meetings. The main topics were prescription coverage, long term care and acute care. Two of the sessions included presentations from Alberta Health Services. We participated in the initial meeting of the Congress of Union Retirees of Canada (CURC) and Alberta Federation of Union Retirees (AFUR) to launch the Pharmacare campaign. This group has remained active and is lobbying with both the Federal and Provincial Governments for action on improved prescription coverage for all Canadians.

The general meeting speakers included the RCMP presentation on Fraud, Alberta Health Services outline of coping with chronic disease and pain, how to access the services of the Ombudsman for Seniors and the new programs offered at the Golden Circle Senior Resource Center plus details of the newly opened Elder Abuse Emergency Shelter for Central Alberta.

The many hours devoted by board members and other volunteers have helped keep seniors informed in Region 5.

INDEPENDENT AUDITORS' REPORT

To the Board of the Alberta Council On Aging Edmonton, Alberta

We have audited the accompanying financial statements of the Alberta Council on Aging, which comprise the statement of financial position as at March 31, 2018 and the statements of operations, changes in net assets and cash flows for the year then ended, and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian accounting standards for not-for-profit organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditors' Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditors' judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Opinion

In our opinion, the financial statements present fairly, in all material respects, the financial position of the Alberta Council on Aging, as at March 31, 2018 and the results of its operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.

Highlights 2017

Participating

Aging 2.0: Improving Experiences for Older People Through Technology and Innovation

World Health Organization webinar, presented by Stephen Johnston of Aging 2.0, to discuss the development and application of technology and innovation in age-friendly environments.

Global Foundation for Sustainability Tour

The foundation is run by Lucien Royer and Judith Basisty, two seniors who are creating an island of trees in Alberta which helps to improve the oxygen levels. The Foundation is home to a wide variety of wildlife, including a number of endangered species.

Finding Solutions to Improve Information and Communication Resources for Seniors Workshop and Networking Reception

Senior Serving Organizations shared ideas and their expertise to help organizations work smarter – not harder – to meet the information needs of seniors in the Edmonton area.

Legislative Assembly of Alberta

Alberta Council on Aging was invited to attend the Legislative Assembly of Alberta session as a guest of Honourable Sarah Hoffman as MLA for Edmonton-Glenora. The Council was introduced to the Speaker of the House and acknowledged for contributions to the vitality and health of community and society.

Rural and Remote Age-friendly Communities Webinar

The webinar focused on what age-friendliness means in the context of rural and remote communities and what factors help or hinder rural and remote communities in becoming more age-friendly.

Private Versus Public Health Care Forum

We were invited to a public forum on the topic of private versus public health care. Political parties as well as health care researchers presented their positions on this topic. There was an agreement that research shows health care needs to be publicly delivered. The entire panel seemed to favour public health promotion and prevention vs sick care.

Educating

Canadian Cultural Mosaic Project on Inclusive Language

The Canadian Cultural Mosaic Foundation is a national non-profit organization that works to create cultural understanding and mitigate isms. Alberta Council on Aging collaborated on an educational project designed to promote inclusive language.

As a result of this collaboration, we have based a new program, "Let's Talk Ageism", on the combined work.

Coffee Break and Dementia Information Session hosted by MLA Sarah Hoffman

We shared a short presentation from Let's Talk Dementia with the assistance of key volunteers.

Reaching Out to Seniors Conference

In partnership with Lac La Biche County and FCSS, Donna Durand presented the Senior Friendly™ Program overview and participated in the Community Blanket Exercise

Recognizing Fraud Launch

The kickoff for Fraud Prevention Month was held in Camrose in partnership with Johnson Inc., Camrose RCMP and the Wise Owls, and Alberta Council on Aging.

Advising

Alberta Human Rights Act Age Amendment

Alberta Council on Aging met with representatives of the Alberta Justice and Solicitor General to submit feedback regarding the amendment of the Human Rights Act to include age.

The council and individual members took part in attending discussions or submitting feedback to government regarding the amendment to the Human Rights Act, to include "age".

Primary Health Care Coalition for Integration

The Primary Health Care Integration Network is focused on improving transitions of care between primary healthcare providers and acute care, emergency departments, specialized services and other community services.

Meeting four times a year, we have a role to play in representing the voice of older people who clearly have a story to tell. Integrated health services is a priority of Alberta Council on Aging.

Seniors and Housing Ministry Advisory Forum

This ongoing forum covers the topics of ageism, aging in the community, and the labour force participation of older workers. The council provides input to inform the plans and strategies of the Ministry.

Seniors Health Priority Setting Partnership Teleconference

We supported the Seniors Health Strategic Clinical Network[™] research priority setting partnership by taking part in the survey and encouraging others to do so.

Alberta Curriculum Roundtable Discussion

We participated in the curriculum roundtable with Minister of Education David Eggen and Seniors and Housing Minister Lori Sigurdson. We shared our thoughts on how to strengthen and improve Alberta's Publications and Media K-12 curriculum. There was a call for organizational submissions, of which we responded to, giving emphasis on the utilization of the Senior Friendly™ Program.

Life My Way with Lifestyle Options

The advisory council met via teleconference to review and discuss the draft Final Report of the Life My Way Butterfly Home Project funded under the Alberta Dementia Strategy.

Health Coalition of Alberta Meeting

We attended this meeting with the Health Coalition of Alberta and Edmonton MLAs. This meeting focused on the two core priorities of the Coalition: access to care and access to medications.
